The Wellmark Foundation's 2022 MATCH Grants

The Wellmark Foundation is offering two competitive Matching Assets to Community Health (MATCH) grant opportunities in 2022. The MATCH grants are designed to support projects that provide access to healthy foods or create or enhance a safe environment to be physically active in. Guidelines and important information are outlined in their [2022 Request for Applications](#).

- Access to Healthy Foods and Built Environment MATCH Grants: up to \$100K with 100% match are due February 16
- Access to Healthy Foods MATCH Grants: up to \$50K with 50% match are due September 21

Opportunity to Join Funder Lab on Philanthropy and Social Movements

The Philanthropy and Social Movements Funder Lab is an opportunity for philanthropic professionals to learn more about contemporary social movements and the needs of movement leaders while exploring approaches to initiate and sustain investments in social movements at their philanthropic institutions.

The lab is an extension of BMP's [Move The Money](#) project, which provides a set of resources for grantmaking institutions to foster their support of social

movements. The 2022 funder lab will be a structured learning and community-building opportunity to delve deeper into the values and practices identified in *Move The Money*.

Professionals from a range of grantmaking institutions are invited to apply, from small family foundations and donor-advised collaboratives to corporate and well-established national foundations. Participation in all sessions of the lab is required, and slots are limited. While the Lab is free, interested individuals/organizations need to indicate their interest [via this form](#) by January 31, 2022.

Nominations open for 2022 Iowa Volunteer Hall of Fame Awards

The Iowa Volunteer Hall of Fame is the most prestigious state-level honor volunteers can receive; the people selected have freely given their precious time and talent in countless ways to benefit others and have forever changed their community, the state, the nation, or the world. Inductees are recognized during a special ceremony held in the State Capitol Building and their names are engraved on the Volunteer Hall of Fame plaque on permanent display in the State Historical Museum. Since the award's inception in 1989, over 175 Iowans have been honored.

Nomination may be submitted by anyone familiar with the nominee's volunteer commitment and impact. Nominees must live or operate in Iowa: individuals, national service members, families, groups, organizations, nonprofits, businesses, or corporations may be nominated.
