Spring Capacity Building Grant Timeline

The <u>Capacity Building Grant Program</u> supports opportunities for qualified community foundations and their affiliates to engage in activities that increase their ability for sustainable endowment building and growth. Grants are available each year in Spring and Fall cycles. The 2023 spring timeline is:

- Pre-application will be available on the ICoF website February 1
- Pre-applications reviewed on a rolling basis through 5 pm on March 1
- Final applications are due by 5 pm on March 31
- Grant applicants will be notified of grant decisions by May 1

The Community Foundation Boot Camp is a virtual training program designed to provide participants with an overview of the structure and operations of a community foundation. CFs are unique and complex organizations and IPA has designed this training to be an intensive dive into all functions of a community foundation. The program is offered in six sessions scheduled over three days and it is recommended that you plan to join each session live:

- February 10 | 9:30-11:30am, 1-3 pm

Legal Training with the Council on Foundations

Wednesday, March 8 & Thursday, March 9 | Noon - 3:30 pm | Cost: \$100* **Each community foundation is welcome to register up to three staff members.**

Led by the Council on Foundations (COF) Legal Team, this virtual workshop is flexibly organized to ensure that your broad legal questions for administering funds, grants, and community foundation activities are addressed. This live, participatory workshop will also provide technical and practical understanding of complex rules and regulations.

Throughout the workshop, sessions will be curated with the help of insight

gleaned from the Council's top-notch legal team that interacts with nearly 2,000 foundation leaders each year, as well as trends spotted by their broader team, including the National Standards for U.S. Community Foundations, a supporting organization of the Council. It will be timely, relevant, and a deeper dive than the basics, surfacing critical insights and expertise to advance your knowledge of the community foundation inner workings -- from administration to governance and donor stewardship to grantmaking. To register:

- Please use <u>Legal Matters for Community Foundations</u>, <u>March 2023</u>, to login and start your registration. If you do not already have a COF login, you'll need to create one first to be able to proceed with the registration process. A new login can be created from the registration page by following the prompts.
- 2. Once logged in you will be asked if you are registering yourself, or a colleague; make your selection and click *Next*.
- Under the "I will be attending as..." section, please select lowa Council, which will then ask you to provide a passcode. The passcode is LM323IAC. Click Next.
- 4. Confirm or edit badge information and answer registration questions. Click *Checkout*.
- 5. Review your cart, and make sure the registration fee is \$100.
- 6. Complete your checkout with provided payment options.

Peer Pointer

With the Spring Capacity Building Grant cycle right around the corner, it is the perfect time to reflect on activities that increase sustainable endowment

building and growth. Last year, ICoF supported a grant to the <u>Quad Cities</u> <u>Community Foundation</u> for data clean up. In their recent grant report, they shared the clean-up was able to help them open 59 new endowments with more than \$1.5M over the course of 16 months.

How did they do it? They leveraged contract relationships with 3 people who knew their system. A former employee did the bulk of the clean-up from October 2021 – November 2022 for an average of 13 hours per month. The two other contractors were already under contract as administrative support for Grantmaking and Development departments. They were assigned a few of the larger, more department-specific, projects (professional advisors, family philanthropy) and logged 40 hours each for these projects.
